**ORDER OF IMMEDIATE
SUSPENSION FROM THE
PRACTICE OF LAW**

This matter comes before the court pursuant to a Petition for Summary Suspension filed on October 28, 2004, by the Petitioner Guam Bar Ethics Committee ("Committee") against the Respondent Raymond T. Johnson, II ("Johnson"). Because the Committee seeks summary suspension of the Respondent pursuant to Rule 13(a)(4)(i) and (ii) of the Supreme Court of Guam Rules for the Discipline of Attorneys, the Respondent Johnson was ordered to appear before a panel of the court at 1:30 p.m. on November 30, 2004, to show cause as to why the Petition for Summary Suspension should not be granted.

Johnson failed to appear, either himself or through counsel, at the November 30, 2004 hearing, and failed to file an answer to the Committee's Petition. Accordingly, and upon consideration of the Petition, Johnson is hereby immediately suspended from the practice of law in accordance with Rule 13(b) of the Supreme Court of Guam Rules for the Discipline of Attorneys. This suspension is made pursuant to Rule 13(a)(4)(i) and (ii) of the Supreme Court of Guam Rules for the Discipline of Attorneys, pending conclusion of several disciplinary matters filed against Johnson. Johnson is ordered to comply with the provisions of Rule 18 of the Supreme Court of Guam Rules for the Discipline of Attorneys.

Pursuant to Rule 19 of the Supreme Court of Guam Rules for the Discipline of Attorneys, the court hereby appoints Attorney Mark Kondas to inventory Johnson's files and to take such action as he considers necessary to protect the interests of Johnson or Johnson's clients. A bill of costs and fees, including reasonable attorneys fees incurred by the Ethics Committee and the court, shall be submitted to the court for approval, and upon approval will be assessed against Johnson.


