More detailed instructions will be given during the testing instructions.

You may be permitted to leave the examination room to use the restroom during the examination; however, all testing materials must remain in the examination room with the proctor and shall be returned to the applicant upon his/her return. No extra time will be given to applicants who use the restroom during the examination.
