Law Week 2015 will be celebrated from April 24 – May 9, 2015, and the Judiciary of Guam, the District Court of Guam and the Guam Bar Association have once again partnered to sponsor the annual Law Day Essay Contest. The essay contest allows students to recognize the importance of the rule of law in our society.

This year marks the 800th anniversary of Magna Carta, a document which has become an international symbol of the rule of law and an inspiration for many basic rights Americans hold dear today. What is Law Day?

Law Day is a national day set aside to celebrate the rule of law. Law Day underscores how law and the legal process have contributed to the freedoms that we all share.

Law Day 2015 Theme:

Magna Carta: Symbol of Freedom Under Law

This year marks the 800th anniversary of Magna Carta, a document which has become an international symbol of the rule of law and an inspiration for many basic rights Americans hold dear today. To enter, students must write an essay addressing the following questions:

1. How did Magna Carta affect the development of the United States Constitution?
2. Are the principles espoused in Magna Carta still relevant today? Why?
3. In what ways can we better adhere to the principles contained in Magna Carta?

Contest Rules:

- Students from 9th-12th grade are eligible to participate.
- Essays must address the questions above.
- Essays must be no more than 1,000 words, typewritten, and double-spaced.
- Essays must be the student's original work.
