**We also want your confirmation that the correct parts, including the services, are not only bid but also sold and Cisco registered with the correct part numbers, the proper service levels, and the correct number of years for those service levels. Note this alone, if not compared “apples to apples” on**

**this bid and monitored properly by the Judiciary of Guam bid team, could make a \$10,000+ swing in the bids – and could create an additional cost for the Judiciary of Guam of thousands of dollars at a later time.**

These are very important factors to ensure that competing bids are sold and registered accordingly with Cisco for every switch. We want to be sure that DCW and all bidding parties are executing to the same software and service support terms.

**Response:**

**The parts have been reviewed with our CISCO support and they are confirmed as the correct parts.**

2. Regarding the **Prime Infrastructure License**, it was part of a solution targeted for customers who makes usage of management of converged wired and wireless networks. It integrates Cisco Prime LAN Management Solutions (LMS) and Cisco Prime Network Control System (NCS) into a single bundle for simplified ordering and license management.

As you can see here, the license has been retired for sale on September 30<sup>th</sup>, 2023 (SKU **PI-LFAS-T**), the End of Support is confirmed to be on September 28<sup>th</sup>, 2028,.

Now, it depends on whether the Judiciary Of Guam is or was using these management platforms or not. If you are not currently using them, there is not much to worry about as it was an included item intended to be used with these centralized management platforms.

**We understand from our CISCO support that the Prime Infrastructure is being replace by CISCO's next generation management capability called Catalyst Center (formerly known as DNA Center).**
