MEMORANDUM:

To: All Prospective Bidders

From: Administrator of the Courts

Subject: **Amendment No. 3**
Re: IFB 24-13; Ballistic Shields and Level 3 Vests

Below are responses to questions submitted to my office:

1. May we request that the delivery period be adjusted to 120 days ARO (After Receipt of Order)?

Response: Delivery period is changed from 90 days to 120 days from issuance date of a Purchase Order.

2. For Item #1 Ballistic Shields, b. Size, kindly note that the sizes mentioned are for hexagonal shields. For the rectangular shields, available sizes are as follows:

- 21" x 36" with Viewport 18.5 lbs.
- 21" x 36" with Viewport and Light 19.7 lbs.

Should we follow the sizes mentioned in the bid specifications, however, kindly note that those sizes are for Hexagonal shaped shields.

Response: We are requesting for hexagonal shaped shields. See attachment 1 photo as sample. The viewport is what is rectangular in shape, not the actual shield. Please follow the size and weight indicated below:

- **21" x 36" with viewport and light 18.1lbs**

3. Could you please specify the quantity of rectangular ballistic shields with a viewport required, as well as the quantity needed with both a viewport and light?

Response: We are requesting for ten (10) hexagonal shields, all 10 to have the viewport and light combination similar to what is pictured below, as listed in Exhibit B & C.

4. My vendor has indicated that they have two styles of Level 3 Threat level IIIA vests. One is the BASIC style, and the other is the MOLLE model, do you have a preference? Both hold 10 x 12 plates.

Response: The Judiciary will purchase both Basic and MOLLE Style. Due to this change, the Exhibit C – Pricing Sheet is revised and is attached. Please use this REVISED Exhibit C- Pricing Sheet when submitting bids.

5. Due to the quantities requested, weight is a big factor in trying to keep costs down, ocean freight is the best way of movement. Ninety days is not the issue of production of the product, it is the logistics. Being that this is the upcoming holiday season, delays are probable. Is it possible to request delivery from 90 days to 120 days?

Response: See response to question no. 1.

Please be reminded that this Amendment shall be acknowledged in your bid. Failure to acknowledge this Amendment No. 3 shall result in disqualification from this IFB.
