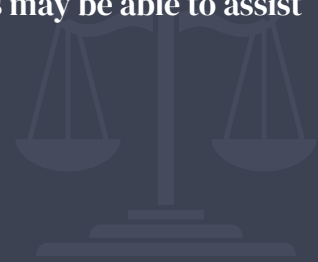

## Civil Law Center-Public Defender Service Corporation




The Public Defender Services Corporation provides effective legal assistance to those unable to acquire private counsel, ensuring equal protection of their lawful rights, in accordance with prescribed ethics, laws, rules, and regulations.

The Civil Law Center (CLC) - The Advocacy Center (TAC) aims to provide no-cost legal advice and services to victims and survivors of domestic violence, dating violence, sexual assault, or stalking. Services from TAC focus on adult women and youths (ages 11-24).

This program does not exclude men.

Services: orders of protection for abuse and dating violence, safety planning, advocacy
