On August 26, 2009, the Self-Represented Litigants (“SRL”) Subcommittee of the Supreme Court of Guam presented three sets of pleading forms to the Court for consideration and approval for use in the Self Represented Litigants – Self Help Computer Kiosks and the Access to Justice interactive software system. The three sets of pleadings include:

1. Uncontested Divorce (no children of the marriage),
2. Petition for Guardianship of a Minor (petitioner is a parent), and
3. Petition for Guardianship of a Minor (petitioner is not a parent).


The SRL Subcommittee submitted the forms to the Guam Bar Association and Judges and Justices of the Judiciary of Guam on May 1, 2009 for notice and comment. The Subcommittee reported to the Court that four persons commented on the proposed pleading forms, that all comments were carefully reviewed and considered, and that the pleading forms were revised accordingly where necessary.

At the hearing of August 26, 2009, modifications were made to the forms by the Court and the matter was taken under advisement pending resubmission of the revised forms. The revised forms were subsequently submitted to the Court.

Therefore, pursuant to the Organic Act of Guam at 48 U.S.C. § 1424-1(a)(6), which authorizes this Court to make and promulgate rules governing the practice and procedure in the courts of Guam, this Court hereby approves the aforementioned pleading forms, copies of which are attached and incorporated herein by reference, for use in the Access to Justice interactive system contained in the

1 Self-Help computer kiosks installed in the Judicial Center and other locations approved by the SRL  
2 Subcommittee.



1. We make this agreement between Plaintiff, **[PLAINTIFF]**, hereinafter referred to as Wife/Husband, and Defendant, **[DEFENDANT]**, hereinafter referred to as Wife/Husband submitted as a Stipulation pursuant to Local Rule 3.1 (a) of Superior Court of Guam.

2. We make this agreement with reference to the following facts:

12 other all such future acquisitions of property as the sole and separate property of the one so acquiring the  
13 same from the effective date of this agreement.

14           8.       We mutually covenant and agree on demand, to execute any other or further instruments  
15 necessary or convenient to carry out the provisions of this agreement.

16           9.       We mutually stipulate that both of us have read this agreement and are fully aware  
17 of its contents and of its legal effect.

18           10.      We mutually stipulate that the court shorten the six (6) month waiting period for a  
19 final decree of divorce.

20           11.      This agreement is entire. We may not alter, amend, or modify it, except by an instrument  
21 in writing executed by both of us. It includes all representations of every kind and nature made by each  
22 of us to the other. This agreement shall be binding upon and inure to the benefit of both of us, and of  
23 our heirs, executors, administrators, successors and assigns.
