RESOLUTION NO. JC 06-026

**RELATIVE TO AUTHORIZING JUDICIARY OF GUAM CONTROLLER TO OPEN AN ACCOUNT FOR THE SPECIFIC PURPOSE OF PROPERLY MONITORING AND ACCOUNTING FOR FUNDS REGARDING CONTINUING EDUCATION AND MORALE, WELFARE & RECREATION PROGRAMS FOR JUDICIARY EMPLOYEES**

**WHEREAS,** the Judicial Council recognizes the importance of providing continuing education opportunities to employees of the Judiciary and of providing various activities for employee participation in efforts to improve workplace morale and welfare and to promote interaction between employees and the community at large in the best interests of the administration of justice; and

**WHEREAS,** the Judicial Council further recognizes that ongoing efforts have been underway, and continue at present, regarding such programs as mentioned above; and


**WHEREAS,** various sources of funds which earmark such programs as mentioned above will exist from time to time, including, for example, a recent CLE event available to members of the Guam Bar Association for a fee which was conducted in conjunction with the Judges & Journalists workshop presented by the National Center for Courts and the Media and from which \$2,380.00 was collected; and

**WHEREAS,** the Judicial Council has determined that in the interest of providing for proper management and accountability of funds relative to such programs, and in keeping with the Judiciary's ongoing commitment to operate in as open, transparent and efficient a manner as possible, the appropriate course of action regarding these programs includes the creation of a separate account regarding funds related to these programs, expenditures from which must be approved by the Judicial Council.

**NOW THEREFORE BE IT RESOLVED** that the Judiciary's Controller is hereby authorized to open a separate account with regards to funds related to the continuing education and morale, recreation & welfare programs of the Judiciary which account shall be referred to as the CE & MWR account and which shall be managed as other accounts of the Judiciary are by the Financial Management Division and into which shall be deposited funds earmarked for such purposes, including the \$2,380.00 recently collected for the CLE event presented in conjunction with the Judges & Journalists workshop presented by the National Center for Courts and the Media.
