



**BEFORE THE JUDICIAL COUNCIL OF GUAM
RESOLUTION NO. JC06-029**

Relative to Expressing sincere gratitude and a Dangulu na Si Yu'us Ma'ase to the Honorable Robert Klitzkie, Senator and Chairman of the Legislative Committee on Judiciary, Governmental Operations and Reorganization for exemplary public service to the People of Guam and the Guam Judiciary.

WHEREAS, after a distinguished career in education, law, military service and criminal justice, Robert "Bob" Klitzkie continued his career as a public servant by being elected and inaugurated as a Senator in the Guam Legislature in January 2003; and

WHEREAS, Senator Klitzkie ambitiously and immediately set out to effectuate meaningful and positive change for the entire island community with his legislative proposals; and

WHEREAS, Senator Klitzkie, a long-time practitioner of law, took great interest in carefully preparing legislation that would benefit the island judiciary and patrons who come before the court; and

WHEREAS, noteworthy among bills that he authored, the Judicial Efficiency Act of 2006, a significant and major law which he drafted after collaboration with court officials and the Guam Bar Association, will result in enhanced judicial services for the public through established time standards and an improved case assignments process for the efficient disposition of cases; and

WHEREAS, the Judiciary, legal practitioners, and the public are beneficiaries of his legislative action which makes a search engine available, free of charge, at the Compiler of Laws website for increased public access to the Guam Code Annotated and Session Laws; and

WHEREAS, he has also demonstrated his advocacy and support for an independent judiciary by ensuring that the judiciary was accorded the respect due to an co-equal branch of government; now

THEREFORE, BE IT RESOLVED, that the Judiciary of Guam expresses utmost gratitude and appreciation to Senator Robert Klitzkie for his exemplary service and contributions to the Judiciary of Guam, and for aiding the Judiciary in developing its capacity to efficiently serve the People of Guam.
