- WHEREAS, Peter J.P. Muna embarked on his service to the People of Guam and our island community in 1965, as a member of the island's law enforcement community with the Superior Court of Guam as a Deputy Marshal; and
- WHEREAS, Deputy Marshal Muna faithfully served and maintained a stellar career with the courts of Guam; and
- WHEREAS, Deputy Marshal Muna worked his way through the ranks for over two decades by serving with dedication, commitment, and professionalism, as evidenced by his well-deserved promotions and record of achievements; and
- WHEREAS, Deputy Marshall Muna became a Supervisor and crowned his Marshal career by being appointed as the Chief Marshal of the Superior Court of Guam by then Presiding Judge Paul J. Abbate in 1985; and
