RESOLUTION NO. JC 07-020**

**RELATIVE TO EXPRESSING A POSTHUMOUS DANGKULU NA SI YU'OS MA'ASE
TO CHIEF PROBATION OFFICER ROY S. TAIJERON FOR EXEMPLARY PUBLIC
SERVICE TO THE PEOPLE OF GUAM AND THE GUAM JUDICIARY**

WHEREAS, Roy S. Taijeron began his service to the People of Guam in 1965 as a Meter Reader for the Public Utility Agency of Guam. Subsequently in 1972, he became a member of the island's law enforcement community with the Superior Court of Guam as a Probation Officer II; and

WHEREAS, Chief Probation Officer Taijeron faithfully served and maintained a stellar career with the Courts of Guam; and

WHEREAS, Chief Probation Officer Taijeron worked his way through the ranks for nearly two decades by serving with dedication, commitment, and a spirit of teamwork and cooperation, as evidenced by his well-deserved promotion and record of achievements; and

WHEREAS, Chief Probation Officer Taijeron realized the pinnacle of his probation career with the appointment to the Chief Probation Officer of the Superior Court of Guam by then Presiding Judge Paul J. Abbate in 1980; and

WHEREAS, Chief Probation Officer Taijeron assumed his leadership position with the Judiciary and contributed valuably to the Judiciary and the Probation Services Division; and

WHEREAS, Chief Probation Officer Taijeron, after devoting nearly twenty years of public service as the Chief Probation Officer, retired from the Judiciary;

NOW THEREFORE, IT BE RESOLVED, that the Judiciary of Guam express utmost gratitude and appreciation to Chief Probation Officer Roy S. Taijeron and his family for his dedicated, and loyal service to the Judges, Probation Division, Judiciary management, Judiciary employees, and the People of Guam; and

BE IT FURTHER RESOLVED, that Chief Probation Officer Taijeron be posthumously honored for his commitment and dedication to our island community.
