



**BEFORE THE 2013 JUDICIAL COUNCIL OF GUAM**

**RESOLUTION NO. JC13-023**

**RELATIVE TO THE ROLLBACK OF TRANSCRIPT FEES**

**WHEREAS**, at the August 2013 meeting of the Judicial Council, Ms. Lolita Limtiaco, in her capacity as the Court Reporter Supervisor, made a presentation to the Judicial Council regarding the market rates for both transcription of recorded proceedings per page and for subsequent copies per page of a transcript. This recommendation was prompted by research that she had conducted, at the request of Chief Justice F. Philip Carbullido, to compare fees of the Superior Court Court Reporters Division to those of the private sector; and

**WHEREAS**, Court Reporter Supervisor Limtiaco presented compelling arguments that the Court Reporter fees as they existed as of April 2011 should be reinstated; and

**WHEREAS**, on motion duly made and seconded, the Judicial Council voted that a new fee schedule for transcription of recorded proceedings as well as subsequent copies of transcripts should be rolled back to the fees existing as of April 2011;

**NOW THEREFORE BE IT RESOLVED** that the Judicial Council hereby **ratifies** the vote taken at the August 2013 meeting of the Judicial Council that a new fee schedule for transcription of recorded proceedings as well as subsequent copies of transcripts, to reflect the fees as they existed as of April 2011.
