RESOLUTION NO. JC14-003**

**RELATIVE TO CONGRATULATING JUDGE TERESA KIM-TENORIO ON THE OCCASION OF
HER APPOINTMENT AS THE NEWEST ASSOCIATE JUDGE OF THE SUPERIOR COURT OF THE
COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS**

WHEREAS, Teresa Kim-Tenorio was appointed to serve as Associate Judge of the Superior Court of the Commonwealth of the Northern Mariana Islands; and

WHEREAS, this appointment marks a very important day in the history as of the CNMI government, as Judge Kim-Tenorio is now the only female on the bench and is the third female judge to have served in the CNMI Judiciary; and

WHEREAS, Judge Kim-Tenorio's employment background includes private practice in the CNMI community, service in the CNMI House of Representatives as Legal Counsel, and finally in the Executive Branch as the Legal Counsel for Governor Eloy S. Inos, who made the nomination and unwaveringly supported her appointment; and

WHEREAS, Judge Kim-Tenorio brings an impressive educational background, her Juris Doctorate conferred by the New England School of Law, and a member of the CNMI (2004) and Michigan Bar (2002); and

WHEREAS, Judge Kim-Tenorio is an active member of her community, a volunteer to various organizations, including an officer for the Marianas High School's Parent Teacher Association, a coordinator of the CNMI Mock Trial Competition, and a trustee for the CNMI Judiciary Historical Society since 2005; and

NOW, THEREFORE, BE IT RESOLVED that the Judicial Council welcomes the appointment of Judge Kim-Tenorio and concurs with their CNMI colleagues that she will greatly contribute toward the administration of justice in the jurisdiction of CNMI; and

BE IT FURTHER RESOLVED that the Judicial Council hereby extends its congratulations to on the occasion of her appointment.
