RESOLUTION NO. JC 14-018**

**RELATIVE TO COMMENDING ATTORNEY WILLIAM J. BLAIR FOR HIS SERVICE TO THE  
JUDICIAL COUNCIL OF GUAM 2003-2014**

**WHEREAS,** on November 20, 2003, new Judicial Council Rules of Conduct and Operation were amended and adopted. Rule 6.02 of the new rules created an Advisory Committee composed of all other judges not a member of the Council, the President of the Guam Bar Association and one other member of the Guam Bar Association appointed by the Chairperson; and

**WHEREAS,** Attorney William Blair is a 1976 graduate of the Hastings College of Law, a 1978 admittee of the Ninth Circuit and a 1982 admittee of the Guam Bar Association, President of the Guam Bar Association from 1986 to 1988, and a revered senior member of the Guam Bar Association; and

**WHEREAS,** as an Advisory Committee member, Attorney Blair actively participated in the discussions of the Council, stated his position on matters under discussion before the Council, and made recommendations for the Council to consider before a vote; and

**WHEREAS,** in the many years that Attorney Blair served on the Advisory Committee, the Judicial Council has been faced with the challenges, with which Attorney Blair provided calm and reasoned counsel. His contribution to the functioning of the Judicial Council throughout its last many years is greatly appreciated.

**NOW THEREFORE BE IT RESOLVED** that the Judicial Council is proud to honor the dedication, diligence and efforts of Attorney William J. Blair, who contributed greatly to the smooth functioning of the Judicial Council for the last eleven years.

**BE IT FURTHER RESOLVED** that the Judicial Council hereby extends *Un Dangkolo Na Si Yu'us Ma'ase* to Attorney Blair for his dedicated service as a member on the Advisory Committee to the Judicial Council and outstanding service to the people of Guam.
