RESOLUTION NO. JC 15-003**

**RELATIVE TO COMMENDING ATTORNEY CYNTHIA V. ECUBE FOR HER SERVICE TO THE JUDICIAL COUNCIL
OF GUAM AND THE BOARD OF LAW EXAMINERS 2009-2015**

WHEREAS, Attorney Cynthia V. Ecube is a daughter of Guam and a 1990 graduate of the Hamline University School of Law, a 1991 admittee of the Guam Bar Association and a 1992 admittee of the Ninth Circuit, Vice-President of the Guam Bar Association from 2001 to 2008, and a revered member of the Guam Bar Association; and

WHEREAS, in 2008, Attorney Cynthia V. Ecube was elected to the Office of President of the Guam Bar Association.
