RENEWAL OF JUDGMENT SERVED  
SEPTEMBER 30, 2016

16 This matter came before the Honorable Katherine A. Maraman on June 1, 2018  
17 on the Defendant's Application for Renewal of Judgment.

18 On or about September 30, 2016, Defendant Jean Richardson served or filed her  
19 Application for Renewal of Judgment. On November 1, 2016, Darius Richardson filed  
20 his Opposition. Jean Richardson served or filed her Response to Opposition to  
21 Application for Renewal of Judgment Memorandum on or about December 19, 2016.

22 On June 1, 2018, the Court ruled from the bench to deny the Application  
23 without prejudice. Based upon those reasons set forth in Plaintiff's Opposition filed  
24 on November 1, 2016, among others, the Court finds that Defendant lacks standing to  
25 assert any claims or rights of non-party Mr. Theodore E. Jackson. Defendant is not  
26 prejudiced nor impaired from assertion of Defendant's rights, whatever they may be,
